INTRODUCTION

The Master of Development and Gender Studies (MDGS) programme is designed to address the critical interrelation between two important areas of global concern: development is a fundamental human right, which has been conceptualized in different aspects and the achievement of which depends on the realization of the intersection of multiple and cross-cutting factors. Gender, on the other hand, highlight the importance of promoting equality in opportunities, access and all people results for without discrimination on the basis of gender identities and norms.

This course of study aims to explore the theoretical underpinnings of these two concepts and their inter-relatedness, emphasizing the importance of integrating both concepts into policy and practice. Through this exploration, students are expected to gain a deeper understanding of the interrelated challenges and opportunities for advancing human development and seek ways and means to effect positive change in their chosen fields.

MDGS is introduced as the first ever masters programme that combines the element of gender rights and development in Sri Lanka. This would be a groundbreaking postgraduate programme that provides a combination of theoretical and practical perspectives on gender and development as two concepts.
